Abstract: Collection contains primarily photographs as well as selected business ledgers and limited miscellaneous documents of William Austin Nunn and Annie Jaggard Nunn as owner/operators of the 7V Ranch in Lonesome Valley, AZ. Also included are Annie's diplomas from grammar school, secondary school and college as well as correspondence related to her Yavapai Cowbelles membership.

Biographical History:

Born Feb 4, 1883 in Runnels County, TX, William Austin Nunn moved to Arizona in 1915 and worked as a ranch hand in Perkinsville. On July 18, 1928 in Williams, AZ, he married Annie Jaggard (born Dec 24, 1888 in Jaggard, KS). A graduate of Baker University (Baldwin, KS), Annie moved to Williams, Arizona in 1922 and taught school at Williams High prior to her wedding. The couple owned and operated the 7V Ranch in Lonesome Valley until it was sold in 1951 prior to settling in Chino Valley, AZ. After her husband passed on Oct. 23, 1965, Annie moved to Samaritan Village in 1978 where she passed on Oct. 13, 1983. She was a member of the Yavapai Cowbelles and the couple were members of the Yavapai Cattle Growers.



Scope and Content Note

The Nunn collection contains three series of records: Series 1 encompasses 57 miscellaneous ranch photos (topically arranged in three files); Series 2 contains several anecdotes as well as official documents including pasture allotments, six business ledgers and teacher's contract (dated May 2, 1925) along with assorted Yavapai Cowbelles correspondence; and, Series 3 includes three oversized diplomas of Annie Jaggard
