**Abstract:** Sharlot Mabridth Hall was the first curator and is the namesake of the Sharlot Hall Museum. Her collection is the cornerstone to the Museum's archives and includes a variety of personal items and records, as well as materials when she was Arizona's Territorial Historian. Sharlot was a pioneer, poet, journalist, editor, author and Arizona's representative for carrying Arizona's votes to the Electoral College in 1924. Her large collection contains personal and Territorial Historian correspondence, diaries, journals, scrapbooks, manuscripts, newspaper clippings, notes, and records.

## **Biographical History**

Sharlot Mabridth Hall was born in Lincoln County, Kansas on October 27, 1870 to James Polk Knox and Adeline Susannah (Boblett) Hall. Her family moved to Lynx Creek, Arizona Territory in 1882, twelve miles southeast of Prescott.

Hall was educated in public schools near Dewey, Arizona, and following high school, she went to Los Angeles to attend the Cumnock School of Expression. Though she did not attend a university, she received an honorary Bachelor of Arts from the University of Arizona in 1921.

Hall became a poet and author, penning a book of poetry, *Cactus and Pine*, including her most famous poem, "Arizona." She was a journalist who contributed articles to a number of publications, and served as editor of *Out West* Magazine until 1909.

In 1909, Territorial Governor Richard Sloan appointed Sharlot as the Territorial Historian. She was the first woman to hold public office in Arizona. She resigned as Territorial Historian in 1912, and returned to her family's ranch, Orchard Ranch, located in Dewy, Arizona. She remained there to care for her aging parents until their deaths. During a majority of this time, she maintained a private existence. However, she reemerged into public life briefly when she was chosen in 1924 to hand carry the State of Arizona votes to Washington, D.C.

In 1927, Prescott leased the original Territorial Governor's Mansion to Sharlot for life. While she lived there, she used her own money and raised public funds to restore the home. She operated the Governor's Mansion and local history museum until her death in 1943. The museum remains today as the Sharlot Hall Museum.

Sharlot Hall died April 9, 1943 in Prescott at the age of 72.

## **Scope and Content**

This collection contains records, correspondence, diaries, journals, scrapbooks, manuscripts, newspaper clippings, notes, and a variety of other materials related to Sharlot Mabridth Hall's personal life, as well as her involvement in Arizona's Territorial Historian, author, poet, journalist/editor, pioneer, and Arizona's representative carrying votes to the Electoral College. Keep in mind that, while the collection is arranged into series based on her different roles and activities, there is some degree of overlap in her life in terms of keeping notes for her writing versus keeping notes as Territorial Historian. Also, materials located in her Manuscripts and Notes sub-series will likely have some overlap with her Arizona and Yavapai County History Series.

The materials in this collection were created and collected by Sharlot Hall, founder of the Prescott Historical Society and Sharlot Hall Museum. Many of the records were in Hall's custody when the museum was established in 1928 and others were created in the course of her work at the museum. A small portion of materials related to Hall's relationship with Frances Gillette was purchased in 1999. Also, some materials were purchased from other sources to add to this collection.

Originally the materials in this collection were processed and placed into an antiquated archival arrangement and organization scheme. The scheme used a document box number system and the materials were originally cataloging in DB 66-DB73 boxes. This





catalog was changed when Archivist Libby Coyner, established SAA best practices and standards into the archives. The textual materials for this collection were re-processed and organization using a standardized arrangement and scheme in 2010 and assigned a new identification number MS-12. Although, a previous inventory and finding aid exists, and is available upon request, a new DACS compliant finding aid was created for the collection. This finding aid was updated when Archivist Brenda Taylor re-processed the photographic items found within the archives in 2013.
